Hearing God

Discerning His Voice

This weekend, we are kicking off our new series: Hearing God... Discerning His Voice.

I'm really excited about this series because the longer I walk with Jesus, the more I'm convinced that learning to recognize God's voice (in the many different ways He speaks) is one of the most important spiritual skills we need to develop if we want to walk well with God, develop a truly personal relationship with him, experience his presence and power, and carry out his vision for our lives.

So, I hope you can join us as we start this series this weekend!

This is such an important topic that we are having all our Life Groups go through the study we are writing for it. The main text we are using (outside the Bible) is *Hearing God* by Dallas Willard.

We sold out of all our copies last week and have ordered more. While we are waiting for them to arrive, we will post a pdf of the assigned reading pages, along with the Life Group study, on our website at rockypeak.org/hearing-god each week.

If you don't have a computer, tablet, smartphone, or printer, we will provide hard copies of both the Life Group study and the *Hearing God* pdf at the Starting Point each weekend until the books arrive.

Even if you are not in a Life Group this session, I encourage you to get a copy of the book and go through this study so we can all grow together as a church in this important area.

Encounter

Hearing God

On **Wednesday**, **January 31**, we will have our first Encounter of the year from **7-9pm** in the Worship Center.

For those of you who are new, an Encounter is a special night set aside to encounter God through prayer and worship. This Encounter will also include a time of celebration for what God has done in and through us at Rocky Peak in 2023.

The primary prayer focus of this Encounter will be to ask God to help us grow in our ability to hear and discern his voice this year-both as individuals and as a church.

It will also include a brief vote on our 2024 budget and elders.

To prepare for this Encounter, we are creating a special three-day Life Group study with short videos to be used on the Monday, Tuesday, and Wednesday before Encounter, and we encourage you to use them whether you are in a Life Group or not.

This past year God has been meeting us in new and powerful ways at our Encounters. The worship center was packed out for the last two and we experienced the presence of God in a powerful way.

So, I hope you can join us!

Please note: As we have shared earlier this month, we are not able to provide childcare for younger children for this Encounter, but older students are encouraged to join us in the Worship Center.

Christmas Generosity Initiative

His Hands On Africa

This year we are partnering with *His Hands On Africa* to renovate the second story of their new Hope Dental Center so they can serve the poor, share Christ, and train and disciple dentists to impact Rwanda with the gospel.

The estimated cost for these tenant improvements and equipment is \$220,000. Our goal was to raise as much of this as possible. **But the amazing news is that we received \$276,000**-which makes it our largest Generosity Initiative ever!

We will be celebrating this milestone this weekend, but I want to thank you now for listening and following and giving so generously! We are excited to see how God will use this new dental center to impact the lives of the Rwandan people, and we will give you an update on this project later this year.

2024 Budget & Elders

A Quick Overview

One of the things we will do at our January Encounter is take a quick vote on our 2024 budget. So, let me give you a brief overview of this year's proposal (see budget attached).

The great news is that our giving in December exceeded our December contribution budget. As a result, we also surpassed our 2023 annual contribution budget! And on top of that, our 2023 expenses were less than budgeted, *so once again, we ended the year in the black*!

This is a tremendous praise and sets us up well for 2024. And once again, *I want to thank those of you who have given so faithfully and generously both in December and all year long!*

This year we are proposing a contribution budget that reflects our actual contribution totals for 2023 and our numerical growth as a church. (We have grown numerically 23% in 2023!)

What this means is that if our 2024 contributions match our 2023 contributions, we will be right on track.

If you look at the expense side of the budget, you will notice that there are several categories that are either more or less than last year's budget or expenditures. When these changes are significant, we have included footnotes to explain them.

As always, our budget is our plan for the year. We can adjust it as we go, but this is our proposed budget as we head into 2024.

If you have any specific questions about the budget, our elders and staff will be available as usual for our Q&A meetings after each service this weekend, **January 20/21** or next weekend, **January 27/28**. These meetings will be held in the conference room in The Vista (the building closest to the solar-covered parking lot).

At the Encounter, we will also be voting on our 2024 elder candidates. We have attached a brief bio on each of these leaders to this letter.

I think that's it for now!

I'm looking forward to seeing you this weekend as we kick off our new series, *Hearing God*, and then at the Encounter on January 31!

- (1) Other Income: Includes interest, rentals, concessions, special activities, camps, and on-campus adult classes.
- (2) Wages & Benefits: Includes all salaries, benefits, insurance, and taxes. The increase in this category includes an Operations Pastor in 2024, small adjustments, and an overall increase in benefit costs.
- (3) Program Ministry Expenses: 2024 expenses reflect costs for new ministry events, additional on-campus courses, and camp cost increases.
- (4) Professional Services: Includes increased costs for current independent contractors and new janitorial services.
- (5) Property Maintenance: 2024 includes additional landscaping and irrigation projects.
- (6) Campus Improvements: Budget includes parking lot repairs, fencing, building improvements, and parking lot lights.
- (7) Capital Purchases: Amounts include tech equipment, vehicle repair, and computers.
- (8) Global Ministries: Amounts include Generosity Initiatives and Mission Trips.
